

Study Area

- Sand Creek Road is owned and operated by both the Village of Colonie and the Town of Colonie.
- The corridor provides critical connections to key community destinations, commercial activity, employment centers, recreation areas, regional transportation hubs, and residential neighborhoods.



Study Objectives

Provide recommendations that will:

- Improve sidewalks and crosswalks for safe accessible pedestrian travel
- Improve bicycle infrastructure to encourage active transportation
- Slow vehicular traffic and create a safer environment
- Enhance the public transportation options to make travel more convenient and accessible
- Enhance the look of the corridor with gateway features and green areas to create a more attractive and sustainable environment

Study Goal


To develop a Plan, endorsed by the Village, that will be used to pursue funding opportunities and guide implementation of improvements.

What is a Complete Street?



Complete Streets are streets designed for all users, all modes of transportation, and all ability levels. They balance the needs of drivers, pedestrians, bicyclists, transit riders, emergency responders, and goods movement based on local context.







Modal Hierarchy

- Used to make well-prioritized design and operation decisions
- Not all modes can be accommodated on all streets (ROW, safety, etc.)

Maintenance

- Future maintenance of physical elements and materials
- Public vs. private responsibility
- Snow removal operations and storage
